PROBLEMS OF STRUGGLE WITH SOCIAL ISOLATION OF PEOPLE WITH SPECIAL NEEDS DURING ECONOMIC CRISIS IN UKRAINE

Disablement, as a social meaning, belongs to special citizens in any country in the world. Today, the population of people with special needs among the inhabitants of the planet reaches the figure of more than a billion people or 15%. The number of people with special needs in Ukraine is about 2.9 million. Almost 80% of this population are working age persons. But, unfortunately, it's unfortunate to talk about equal opportunities for employment, adapted infrastructure and education for them. People with disabilities are not simply depend on out-of-pocket help - they are not in a position to overcome the informational, physical and psychological barriers. This state of affairs is shameful and unacceptable for a civilized European state. Because disability is not a verdict, people with special needs can and will become full-fledged and highly effective members of society, excellent specialists, socially active and cheerful people who can inspire a lot of people, including absolutely healthy members of our society.

Social policy and its impact on the implementation of social assistance to people with various physical and mental disabilities are very important in solving this problem. Social policy on addressing the issue of people with special needs in Ukraine is at the stage of formation. Social legislation is developing, social opinion is changing. However, social policy in Ukraine, focused on the disability of adults and children, is being built today on the basis of a medical model. Such a model freely or unknowingly weakens the social position of a person with a disability, reduces its social significance, separates from society, increases its unequal social status, condemns it to recognition of its inequality, uncompetitiveness in comparison with other people. Such an approach carries a discriminatory idea, reveals the attitude of society towards persons with disabilities as a socially useless category.

In 2009, Ukraine ratified the United Nations Convention on the Rights of Persons with Disabilities, which, together with the protocol, came into force on February 4, 2010. However, it should be noted that in the current conditions of the political and economic crisis in Ukraine, fulfillment of the undertaken obligations becomes extremely problematic.

In recent years, certain measures have been taken and a number of important legal acts aimed at realizing the rights of people with disabilities and ensuring their full participation in the life of society have been adopted. But, unfortunately, in life these laws remain so "dead".

Today, the situation of persons with disabilities, the situation in which they are in fact did not change. In today's conditions of economic instability, the people with special needs were one of the most socially vulnerable groups of the population. The main problem that requires an immediate solution is overcoming the social isolation of persons with disabilities, the limited ability to communicate with them, organizing their leisure time, studying, obtaining a profession, finding possible earnings.

Work for a people with special needs is more than an improvement in the well-being of his family; This is, first of all, the possibility of self-affirmation, self-realization, a sense of necessity for society. Socially-provided, decent life for people with disabilities can only be talked about when they are competitive in the labor market. At present, the unemployment rate among the disabled has substantially increased, it is much higher than among the healthy population, and it varies depending on many indicators - the type and groups of disability, health, age, gender. The work of people with disabilities, as a rule, is low-wage, and in spite of its loss, the legislation does not stipulate the provision of a disabled person the status of the unemployed.

It should be noted that to date, the state does not have a comprehensive strategy for the employment of people with limited functional capabilities. It is precisely the work "returns a person to life" and that is why employment is an important stage in adapting a person to a society and professional rehabilitation of people with special needs.

CONTRIBUTION OF TURKISH THOUGHTS TO THE WORLD HERITAGE

Political revival due to the fall of the Caliphate gave a powerful impetus to the development of science, culture and art among the Turkic peoples. Emerging independent feudal states were paid attention to the development of science, enlightenment, collected advanced people in palaces, built mosques, bridges and magnificent palaces. A large number of madrasas, famous throughout the East, functioned in the cities. Primary schools studied the Quran in the mosques.

The well-known mathematician Abu Abdullah Muhammad bin Musa al-Khwarizmi wrote a number of works on astronomy, geography and mathematics. His book "Kitab ul-Jabr ve Mukabele" (Algebra) was translated into Latin. Al-Khwarizmi was the founder of not only algebra, but also trigonometry.

Al-Farabi who was the great thinker of the East, wrote numerous works on philosophy and logic. In the work "Ihsa ul-Ulim" ("Number of Sciences"), Al-Farabi gives a classification of sciences. He is considered the founder of the science of logic after Aristotle. One of the great scientists of Central Asia and the whole East was Abu Reyhan bin Muhammad al-Biruni Al-Khwarizmi (973-1048). The scientist-encyclopedist lived in Ghazna and wrote over 100 works on philosophy, history, geography, mathematics, astronomy, mineralogy, physics, etc. He proved the rotation of the Earth around the Sun the first 500 years before Copernicus.

The great scholar of the East Ibn Sina in Europe is glorified as "Avicenna." Ibn Sina wrote a 5-volume book about medicine "Al-Qanun fit-tibb" (Law of Medical Science), an
